ADMINISTRATIVE...... Tiffany Clement

## CITY OF CITRUS HEIGHTS......Meghan Huber

- Amendments to massage parlor ordinance. Still going with the same concept, limiting the number of massage parlors in the City, but with specific language which carves out corporate brands such as Massage Envy that offer other services.
- Citrus Heights Business Attraction Program was approved by the council. The goal of the program is to identify and attract new businesses that serve to diversify the City's economic base and/or enhance community. The grant will target specific industry categories including:
  - Restaurants restaurants, bars, coffee, and tea shops (national chains do not qualify)
  - Breweries and other craft beverage businesses, brewpubs
  - Entertainment such as bowling alleys, movie theaters, and entertainment venues

There is some flexibility for sites that have been vacant for five or more years.

#### SECURITY & MAINTENANCE ...... Kathilynn Carpenter/Officer Schouten

- Public Safety Committee/ Public Safety Meeting Friday, April 28 at Noon
  - We will be hosting our second Public Safety meeting on Friday, April 28<sup>th</sup> at noon. We encourage each property's loss prevention staff, and private security to join. The meeting will be led by Officer Jeff Schouten and Nor-Cal Security. This will be a great way for everyone to network, find the issues, tips on CEPTED and give feedback. There will be training on report writing.
- Security Report
  - CHPD Report: Crime stats for first quarter were presented. Shoplifting reports were down 42% due to the ongoing presence of Officer Schouten and Nor-Cal security. Burglary from vehicles was up 33%, Highest crime is burglary/theft from vehicle reports, up 33% and homeless related calls were up 32%. The biggest issues continue to be with organized retail theft, transients and property damage.
  - NorCal Report: Biggest issues are with transient camps and vandalism, along with theft prevention. High target businesses, Hobby Lobby, Lowe's, Marketplace at Birdcage, Macy's, Rite Aid, Sunrise Mall, Target, and Walgreens. Nor-Cal officers have regularly prevented theft and recovered merchandise.
- Maintenance Report
  - City Wide Porter is available Monday through Friday, 11am-3pm. If your center needs assistance, please call Kathilynn first.
  - In the month of March, City Wide collected 74 shopping carts, 62 bags of trash, and removed more than 10 graffiti tags. The porter is directed to match the paint exactly if front facing building and to match as close as possible in areas such as loading docs and trash enclosures. We continue to experience a high number of incidents of resident dumping.

ECONOMIC DEVELOPMENT......Kathilynn Carpenter

- **SMUD Business Attraction Grant:** This is a \$10,000 restricted grant to attract tenants to our vacant buildings. Staff is developing a landing page for the website, and a digital brochure with stats and data for brokers and others.
  - Attract potential tenants for vacancies (6060 Sunrise Vista, Sunrise Mall, Marie Callenders, etc.)
  - Website landing page
  - Digital leasing brochure
  - Additional customized assistance
  - Business Walk

**CPTED (Shine) Grant**- Staff also received \$20,000 in funding through SMUD's Shine grant program. SMP must provide a \$10,000 match. The funds will be used on targeted problem properties which experience significant property vandalism and residents dumping items and debris. Funds will be used to implement CPDTED assessments, which will primarily feature additional lighting. Funds must be used for this purpose.

**TOT Grant-** We have also applied for a \$50,000 Transient Occupancy Tax grant through the County. This is also a restricted grant to be used for security and maintenance.

**City ED Grant-** SMP has also applied for a \$20,000 grant to be used to increase public art in the District. SMP will provide a \$10,000 match. Please contact Kathilynn if you are interested in a mural at your property.
