- Space for vendor in VIP Lounge at Brews in the Burbs
- Electrical needs must be outlined in agreement
- Sampling booth vendor to operate

Vendor to provide:

- · All materials needed to operate the food sampling booth, incuding staff, signage, and food samples for distributing to 300 VIP customers.
- All contractors/vendors performing work at Sunrise MarketPlace are required to furnish a certificate of insurance prior to the event.

INSURANCE REQUIREMENTS

• Vendor is required to furnish Sunrise MarketPlace with certificate of insurance prior to the event date.

LIMITS

FOOD VENDOR REGULATIONS

- All food sampling will take place in the VIP Lounge area of the venue.
- Vendor to comply with all reguations, licenses and permits (health, fire, building, etc.) as required by the city, county, state and federal governing agencies. SMP will send out a packet of information to be returned to SMP to be filed as part of a Master Health Permit.
- Vendor staff will be professional, courteous and respectful and will conduct business according to the contents of this agreement.
- Vendor to supply lighting and all equipment needed for the space.
- Neither SMP, nor Sunrise Mall is responsible for damaged, lost or stolen items.
- Vendor must have a presentable, clean and attractive booth and may be asked to make modifications should they not meet the standards of the venue.
- Set Up/Breakdown: All exhibitors must be set up and ready to sample food by 3:30 pm. Exhibitors may begin setting up at 1pm the day of the event. Breakdown can start no sooner than 8:15pm on Saturday and must be completed by 10pm. Before leaving, be sure your area is clean and trash-free.
