- **RV Parking** - The issue of recreational vehicle (RV) parking in the region has reached a concerning level, particularly with multiple RVs stationed on the rear side of the Target store. Lieutenant Wes Herman has indicated that the Citrus Heights Police Department is dedicated to addressing this matter. Officers will engage directly with individuals who have been residing in their RVs to facilitate a resolution. This initiative forms part of a broader effort to utilize problem-oriented policing strategies to meet the specific needs of the community effectively.

- **Illegal Dumping Strategy** - The issue of illegal dumping has increasingly become a significant concern at Sunrise Mall. The Sunrise MarketPlace (SMP) has conducted clean-up efforts for multiple illegal dumps that appear to be associated with a trash hauler or construction site. Furthermore, an individual has been identified as being linked to several of these large dumps. As a result, SMP is formally requesting the Citrus Heights Police Department to address this matter, either by sending a letter or by directly contacting the individual in question.
