New Businesses:

- Skechers moved from Citrus Town Center to the former Walgreens.
- Citrus Heights Chamber has moved into Greenfaire Village.
- A mattress store is planned to fill in former Skechers business in Citrus Town Center.
- A new tenant is lined up for the former Boston's Pizza- business is not yet public.

Economic Development Updates:

- Bourbons & More applied for approval of their Public Notice of Convenience/Necessity.
 City Council declined approval of the PCN. City is assisting the business in looking for a different location.
- City Manager Feeney released a public safety statement outlining new law enforcement strategies to mitigate crime in the City. The statement encouraged businesses and residents to report criminal activity.
- Business Incentive Grant. Of the \$1 million available, \$86,000 was granted to Dark Heart Brewing, which is relocating to Auburn Blvd. The grant has now expired. The City's is interested in seeing more breweries, entertainment uses and sit-down restaurants.
- Ethan Conrad will be presenting an amendment to Sunrise Tomorrow Plan. This is a presentation to get feedback from the Council and not an approval item.
